

COUNTY TRAINING PROGRAMME

FURTHER INFORMATION FOR PARENTS/GUARDIANS

AT TRAINING CAMPS

PARENT/GUARDIANS HAVE THE RIGHT TO:

1. To know that we will look after your child at the camp.
2. Be informed of any problems or concerns relating to your child.
3. Be informed if your child is injured.
4. Have contact details for your child's captain and members of the support team.
5. Feedback from the Lead Captain for your squad regarding your child.
6. Know that the programme will be led by LTA Level 4 Accredited+ or LTA Level 3 Accredited+ coaches, assisted by other LTA Accredited coaches.
7. Know that the Coach ratio at the sessions will be the LTA requirement for the programme.

PARENT/GUARDIAN RESPONSIBILITY FOR COUNTY TRAINING CAMPS:

1. Players **MUST BE** accompanied by the Parent/Guardian or designated adult to be signed in by the welcoming squad captain.
2. Please be punctual.
3. At the end of the camp, **you must** collect your child from the lead captain for your squad who will sign them out. N.B. Players will not be signed out if you are not there. 16U children will not be able to sign themselves out.
4. Please remain on-site for the duration of the camp in case your child needs to leave the court for any reason.
5. Please communicate early on your child's attendance at each camp.
6. Do mention any concerns about your child to the lead captain for your squad.
7. Please note that Wiltshire Tennis does not accept responsibility for children before signing into the camp and once they have been signed out.
8. Please report any concerns to the lead captain.
9. Do encourage your child to embrace the opportunity to gain experience and independence.
10. Please support the captains' decisions.
11. Please respect the routine of the camp.
12. We are all governed by the LTA Disciplinary Code (effective January 2023). As a minimum, please adhere to our Guidelines for Conduct on the Wiltshire Tennis website. [Safeguarding Documents - Wiltshire Tennis](#)
13. Please contact the County Performance Co-ordinator over any concerns regarding the camps.

15. Please ensure your child has appropriate clothing, equipment and drinks for conditions at the camps.
